



# Up to £50 M&S Voucher Promotion

**Terms & Conditions - Start date 17 June, end date 30 October 2024**

## **1. The Promoter**

- 1.1 The Promoter is Marks & Spencer Financial Services plc, Kings Meadow, Chester CH99 9FB. However, this gift is being administered and managed on behalf of Marks and Spencer Financial Services plc by The Marketing Lounge Partnership (MLP), The Cowshed, Walnut Tree Farm, Lower Stretton, Cheshire, WA4 4PG.

## **2. The Promotion**

- 2.1 Customers who obtain a quote for a new M&S Pet Insurance policy (a "policy") from 00:01 on 17 June 2024 (the "Opening Date") until 23:59 on 30 October 2024 (the "Closing Date") (inclusive) and purchase that policy within the quote validity period will receive M&S vouchers (the "vouchers/gift") to spend in store (the "gift"). Customers purchasing a Premier policy will receive £50 M&S Vouchers, customers purchasing a Plus policy will receive £25 M&S vouchers and customers purchasing a Standard policy will receive £15 M&S Vouchers.

## **3. Eligibility**

- 3.1 The promotion is only open to customers who are:
- (a) aged 18 years or over;
  - (b) permanent residents of Great Britain and Northern Ireland (excluding Channel Islands and the Isle of Man);
  - (c) purchasing a policy from RSA on the M&S Pet Insurance website or over the M&S Pet Insurance telephone lines; and
  - (d) purchasing a new policy.
- 3.2 Customers who purchase an "Essential Cover" policy are not eligible for the gift.
- 3.3 Customers who are renewing or amending policies are not eligible for the gift.
- 3.4 Customers who purchase a policy through a comparison, affiliate or cashback website are not eligible for the gift.
- 3.5 You will be eligible for your gift if your policy is still active and has not been set to cancel by you or the insurer (RSA), within 30 days of receipt of your first payment.

- 3.6 By purchasing a policy within the Opening Date and Closing Date, you confirm that you are eligible to receive your gift.

- 3.8 The Promoter shall have the sole decision on whether any eligibility requirements have or have not been met.

- 4.3 The Promoter reserves the right to substitute the gift with a gift of equal or greater value.
- 4.4 The gift is valid for single use only and can be used in full or part payment. No change will be given if the full value of a gift is not spent.
- 4.5 The gift is not transferable, for auction, sale or re-sale or redeemable for cash and there is no cash alternative.
- 4.6 If your gift has an expiry date it must be used or redeemed before that date.
- 4.7 The gift is subject to further terms and conditions, please read these carefully.
- 4.8 The gift cannot be used in conjunction with other offers, gifts, promotions or prizes. This includes the use of vouchers which were received from purchasing multiple pet policies during this promotion. You are only entitled to one gift per pet insured.
